CRITICAL TURNING POINT

On the eve of our centennial anniversary in 2017, we have the unique opportunity to prepare for a successful 2nd century of service on the NDSU campus. While our brotherhood is rock-solid, our historic chapter home can no longer provide for the key needs of today's students – including safety. Theta Chi is the largest fraternity on campus, but the number of young men choosing to live at the chapter house continues to decline. This impacts brotherhood bonds and our bottom-line. If left unchecked our ability to recruit the best and brightest on campus may diminish. In response to an aggressive student housing market, NDSU and local developers have invested millions in dormitories and apartments in recent years, and three of our top Greek competitors have conducted full-scale renovations. After 85-years of service, the time to invest in Phi is now!

PHI NOW

Working with undergraduates, parents and architect YHR Partners, a comprehensive renovation plan for our 13,000 square foot home has been developed. It received strong endorsement from 38 Phi alumni in a 2012 feasibility study. The punch list includes:

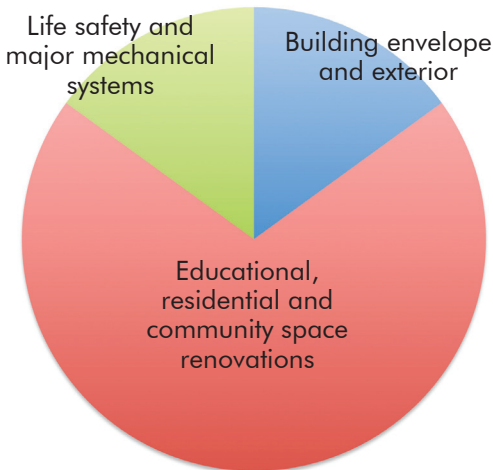
- Install life safety enhancements including sprinklers
- Upgrade major mechanical systems to improve safety and reliability
- Add study space and reconfigure living areas on the 2nd and 3rd floors
- Improve 1st floor accessibility
- Restore the main floor while maintaining its historical character
- Renovate kitchen

A building subcommittee led by Russ Handegard has been appointed to oversee the design and construction process.
